#### 3. CHILD OF THE MONTH - presented by Nicole Sergent

Santiago, C.M. Just about 2 years old. Came to NI in March 2015. **Diagnosed with Cerebral Palsy** Mother: Karina Father: Victor - construction truck driver Live in San Juan Tecomatlan, Poncitlan Mother was told he would be a vegetable. He is having therapy at CRIT three times a week and having physical, speech and eye therapy sessions. Santiago listens, responds with gestures and sounds He is on anticonvulsant medication. If they can control the convulsions he will be able to speak but each time a seizure happens he is set back. He can now hold up his head and they are going to use a special bar to try to straighten his hip. He is now wearing glasses and while there was a plan to do eye surgery it has been postponed as he is responding to glasses. Karina is pregnant and there is no indications of problems with this baby. NI has provided help with medications and transport to approx.

\$15,235 pesos to date.

### 4. Board Reports:

#### Treasurer's Report by Larry Wynant

Treasurer noted that our average monthly expense in 2016 after two months is roughly 7% higher than 2015 at \$ 192,000 a month. No new event revenue was earned in February.

## **Clinic Reports:**

Ajijic Clinic - February – 13 families served - \$14,864 pesos disbursed Chapala Clinics –February - 72 families served over 2 clinics and \$89,036 pesos disbursed Jocotepec Clinics –February - 50 families served over 2 clinics and \$76,693 disbursed.

It was noted that 161 children are currently enrolled with NI. Eight have been terminated and another 10 are due to age out over the next 12 months.

Linda Hendy indicated there was nothing new to report. Howard Plotkin noted that the Mardi Gras parade was once again a very big success due to Patsy Smart and Ann Heath.
